Monthly Returns: This report must be filed and the taxes are due and payable to the Nation on the fifteenth day of each month following the month in which the taxable sales were made. Any taxpayer who shall fail to pay such tax within five days from the date upon such payment shall become due and payable is subject to a penalty of up to twenty-five percent (25%) of the amount of such tax, plus interest, at the rate of one percent (1%) per month or fraction thereof until paid.

Treasurer to correct error: If the taxpayer makes an error in computing the tax assessable against him, the Treasurer will correct such error, re-asses the proper amount of taxes and notify the taxpayer of this action by mailing him a copy of the corrected assessment, and any additional tax for which such taxpayer may be liable must be paid within ten days after the receipts of such statement.


