FEE & PAYMENT

The Tohono O'odham Nation provides an opportunity for Artists and Craftsmen to display and see their wares during the (3) days of the Rodeo and Fair at either the Main Park or the Pow Wow Grounds.

Main Park: Cost of \$100.00 for Native American (proof required) and \$200.00 for Non-Native Americans. Vendors must be present in the booth at all times.
 Pow Wow: Cost of \$50 for Native Americans (proof required) and \$100 for Non-Native Americans. Vendors must be present in the booth at all times.

In addition to the stated fee all vendors are required to obtain a Transaction Privilege Tax License issued by the Nation's Office of the Treasury: pursuant to Title 22-Taxation, Chapter 2-Transaction Privilege Tax, Section 3 4. Privilege License, B. Retail License. The fee for the Transaction Privilege License is five dollars (\$5.00).

Spaces will be assigned on a first come first serve basis. Upon receipt of your completed application and payment in full, a space will be assigned. Times for set-up are as follows, **NO EXCEPTIONS:**

- **Friday, February 1, 2019: 7AM- 8AM**
- **Saturday & Sunday, February 2 & 3, 2019: 6AM-7AM**

NO vehicles will be allowed on the premises. On site sharing of spaces will not be allowed and will be subject to removal or additional fee charged. Vendors must keep space respectably clean and clear of trash. Items sold by vendors that are determined hazardous, harmful or damaging to the public or property as well as items of endangered species, sacred ceremonial status or prehistoric artifacts will immediately cease to be sold when directed by appropriate local authorities. Failure to abide with the set up times described above and these regulations may result in immediate removal, including all vehicles affiliated with the vendor space, from the Rodeo and Fair Grounds.
