Continue with collaborative partnerships with local entities to assist with Native language preservation; develop the O'odham Youth Media into a viable stream focused on the young population of the Nation; and be a resource to the Nation leadership in providing critical information to the general public during the ongoing pandemic.

The on-going pandemic has provided challenges in continuing to provide services of Nation's general public's interest. Through on line applications, Hewel Ni'ok has been able to inform the general public of critical information on Covid-19. Working with the Nation's Office of the Chairman and Vice Chairwoman, Tohono O'odham Legislative Council, Tohono O'odham Health Care Network and the Office of Emergency Management, critical information and medical updates were broadcast to the general public.

Timely and relevant information about the covid-19 virus, as well as regular updates, provided in the O'odham language, kept the communities of the Tohono O'odham updated and gave guidance to testing and vaccinations. While there are not specific data, Hewel Ni'ok believe it has been a major vehicle for informing the communities and residents.

Hewel Ni'ok continues its collaborative efforts in assisting with the preservation of the O'odham language. A two hour immersive program is broadcast on its low power station, KWAK-LP, during the workweek. In addition, Hewel Ni'ok continues with its progression to providing a Youth Media channel as an outreach towards a segment of the population that it has not been reaching through its on-air operations. It is expectation that this channel will be available in 2021.

5. Please assess the impact that your CPB funding had on your ability to serve your community. What were you able to do with your grant that you wouldn't be able to do if you didn't receive it?

During the Covid-19 Pandemic, the funding resource from CPB has helped in maintaining a level of broadcasting and programming that benefits the members of the Tohono O'odham Nation. Through these resources there was never an interruption of services to the communities of the Nation. Hewel Ni'ok was also able to accommodate its staff during the hardships of having to quarantine due to exposure to covid-19, minimizing economic hardship that would have prevailed.
