

Tohono O'odham Nation Tribal Member COVID-19 Vaccine Incentive Program

## **Frequently Asked Questions**

- 1. When will I get my incentive? Once an application is submitted and your vaccine status is verified your check will be processed. The Nation will begin mailing checks out on October 9, 2021. Processing time may vary.
- 2. **How will I receive my incentive?** Every member who qualifies for the Tribal Member Vaccine Incentive Program will receive a physical check, delivered through regular mail.
- 3. What if I misplaced my Vaccine Card?
  - A new card may be issued to you at most vaccine sites. Please contact them directly.

  - You can access your Arizona state immunization vaccine records by registering at: <u>ADHS AZ MyIR (azdhs.gov)</u>.
- 4. **Do I still qualify for the program if I received my vaccine(s) outside of the state of Arizona?** Yes. Submit your vaccine card with your application. If you do not have a vaccine card please contact the state health department in the state you were vaccinated to obtain a new card.
- 5. Who qualifies for the Tribal Member Incentive Program? All enrolled members of the Tohono O'odham Nation, 12 years and older, who are fully vaccinated (2 shots for Moderna and Pfizer; 1 shot for Johnson & Johnson/Janssen) by November 19, 2021 qualify for the program.
- 6. **Does my child qualify for the program?** Yes. Children 12 years and older who have been fully vaccinated against COVID-19 qualify for the program. Applications must be completed and signed by a parent or legal guardian.
- 7. Do I qualify for the Tribal Member Vaccine Incentive Program if I applied and was approved for the TON Employee Vaccine Incentive Program? No. All members of the Nation only qualify for *one* vaccine incentive distribution.
- 8. What if I only received one vaccine of Moderna or Pfizer by November 19, 2021? If you are not fully vaccinated by November 19, 2021, you do not qualify for the Tribal Member Vaccine Incentive Program.

9. How do I get the application to apply for the Tribal Member Incentive Program? Members may submit an application electronically at <u>www.tonation-nsn.gov</u>, by computer or mobile device. If members cannot access application electronically they may contact Enrollment by phone or email to request an application by mail:

- 10. Where do I submit my application for the Incentive Program? All applications and supporting documentation shall be submitted electronically (computer or mobile device) via the link found at <u>www.tonation-nsn.gov</u>. If you are having difficulties submitting documentation electronically, please contact the Enrollment Office specialists directly at (520)383-8700.
- 11. When is the last day to apply for the program? Applications will be accepted September 13, 2021 through December 31, 2021. *Applications will not be accepted after December 31, 2021*.
- 12. Is the Incentive Taxable? No. The vaccine incentive qualifies for tax-free status under the Nation's General Welfare Program.
