



Tohono O'odham Nation Minor Vaccine Incentive Program Ages 5 - 11

Frequently Asked Questions

- 1. When will the minor receive their incentive?** Once an application is submitted and their vaccine status is verified, incentives will be mailed out approximately two (2) weeks from approval, or arrangements can be made to pick up incentives in Sells, AZ.
- 2. What if I misplaced the minor's Vaccine Card?**
 - A new card may be issued at most vaccine sites. Please contact them directly.

- 3. Does the minor still qualify for the program if they received their vaccine(s) outside of the state of Arizona?** Yes. Submit the minor's vaccine card with their application. If they do not have a vaccine card please contact the state health department in the state the vaccination was received to obtain a new card.
- 4. Who qualifies for the Minor Vaccine Incentive Program?** All enrolled Tohono O'odham Nation members between the ages of 5 and 11, who are fully vaccinated (2 shots for Moderna and Pfizer; 1 shot for Johnson & Johnson/Janssen) qualify for the program.
- 5. What if the minor turned 12 years of age after November 2021?** If the minor turned 12 years of age after November 2021 (cut off date for Vaccine Incentive Program for 12 years and older) and did not already receive a cash incentive under the *Tohono O'odham Nation Vaccine Incentive Program* for 12 years and older, the minor may choose between a cash incentive or an incentive under the *Minor Vaccine Incentive Program*. - 6. What if the minor only received one vaccine of Moderna or Pfizer?** If the minor is not fully vaccinated they do not qualify for the Minor Vaccine Incentive Program. The minor may become eligible on the same day that second vaccine is received.
- 7. How do I get the application to apply for the Minor Vaccine Incentive Program?** Parents/Legal Guardians of enrolled members between the ages of 5 and 11 may submit an application electronically at www.tonation-nsn.gov, by computer or mobile device. If you cannot access the application electronically, you may contact the Tohono O'odham ARPA Team, DeAnza Anderson at (520)383-2028, Ext. 2207, or Drew Stevens at (520)383-6600, Ext. 2269, to request a hard copy of the application.

8. **Where do I submit the minor's application for the Incentive Program?** All applications and supporting documentation shall be submitted electronically (computer or mobile device) via the link found at www.tonation-nsn.gov. You may also submit a hard copy application by U.S. mail at the following address:

9. **When is the last day to apply for the program?** Applications will be accepted through September 30, 2022. Minor must be fully vaccinated and submit an application postmarked by September 30, 2022 to qualify for an incentive.
10. **What if the minor received an incentive distribution during a pop-up event in the community?** Eligible applicants may only apply for and receive one (1) incentive. Applications will be denied if an incentive was already dispensed for the minor.
11. **Does the eligible minor get to choose their incentive?** No. Incentive distributions are made based on what is age appropriate and while supplies last.
