**ARTS & CRAFTS BOOTH APPLICATION**

DEADLINE: JANUARY 19, 2024

The Tohono O'odham Nation provides an opportunity for Artists and Craftsmen to display their wares during the Fair at the Main Fairgrounds. A 10' x 10' vendor space is available at a cost of **\$100** for Native Americans (**proof of enrollment or CIB required**) and **\$200** for non-Native Americans. Spaces are also available at the Pow Wow grounds for a fee of **\$50.00** for Native Americans (**proof of enrollment or CIB required**) and **\$100** for non-Native Americans). There is no electricity, so you will have to provide your own power source for lighting.

Deadline to submit an application and payment is **JANUARY 19, 2024**.

All vendors are also required to obtain a Transactional Privilege Tax License issued by the Tohono O'odham Nation Office of the Treasury. The Transaction Privilege License fee is **\$5.00**. The application can be accessed at [www.tonation-nsn.gov/tax-information/](http://www.tonation-nsn.gov/tax-information/) or picked up at the Rodeo and Fair Office.

Upon receipt of your completed application and payment in full, a booth space will be assigned.

**ARTS & CRAFTS BOOTH RULES, REGULATIONS, AND RESPONSIBILITIES**

1. Times for set-up are as follows, **with NO EXCEPTIONS:**
  - Thursday, February 1, 2024: 7:00 AM- 8:00 AM
  - Friday, Saturday & Sunday, February 2, 3 & 4, 2024: 6:00 AM-7:00 AM
2. NO vehicles will be allowed on the premises.

3. Onsite sharing of spaces will not be allowed and will be subject to removal or an additional fee charged.
4. Vendors must always be present at their booth during the duration of the Rodeo.
5. Vendors must keep the space clean and clear of trash.
6. If local authorities determine a vendor is selling items determined to be hazardous, damaging to the public or property, items of endangered species, sacred ceremonial status, or prehistoric artifacts, the vendor must immediately cease selling those items.
7. Failure to abide by the set-up times described above and these regulations may result in immediate removal, including all vehicles affiliated with the vendor space, from the Rodeo Grounds.
8. The arts and crafts booth will be the sole responsibility of the vendor. The Tohono O'odham Rodeo & Fair Office is not responsible for the loss or theft of any item from the booth.

**WAIVERS:** In consideration of being allowed to participate in the Tohono O'odham Nation Wapkial Ha-Tas as an Arts & Crafts Vendor, I, the undersigned vendor or Parent/Guardian of Vendor, hereby acknowledge that by attending and/or participating in Wapkial Ha-Tas, I am assuming all risks, including but not limited to, illness, injury, death or property loss and agree to release the Tohono O'odham Nation, its departments, programs, agents, sponsors, and volunteers from liability, including all legal actions whatsoever arising out of or related to any loss, damage, or injury, including death which may be sustained by me or by any property in my possession or control while in, or upon, the premises. I am aware of the risks and hazards inherent upon entering said premises and/or participating in any of these events, and I elect and voluntarily assume all risks of loss, damage, and injury, including death, to me or said property. This release shall be binding upon me, my heirs, next of kin, executors and administrators and I acknowledge and represent that I have authority to execute this waiver. I am also aware that these premises are drug and alcohol free.

I understand that I assume sole responsibility for any accident, loss, or damage to my booth and wares that may occur.
