The 85<sup>th</sup> Annual Tohono O'odham Nation Rodeo Wapkial Ha-Tas will be held February 1-4, 2024. The exhibits are always a popular part of the annual event. It also presents an opportunity for organizations operating within the Nation to showcase their resources. Please note: exhibitors are <u>strictly prohibited</u> from selling any items at their exhibition booth.

We are asking the Nation's individuals, Districts, Schools, Tribal Departments and non-profit organizations to make every effort to participate.

## EXHIBIT RULES, SPACE SPECIFICATIONS AND GUIDELINES

- 1. There is no fee to register an exhibit booth.
- 2. The deadline to turn in registration forms for exhibit space/s is Wednesday, January 17, 2024. The Exhibit Registration Form must be emailed to TONRF@tonation-nsn.gov. (*NOTE: Space is limited and will be assigned on a first come, first served basis.*)
- Exhibits must be set up between the hours of 8:00 AM to 5:00 PM on Monday & Tuesday, January 29 & 30, 2024. Last minute adjustments can be made on Wednesday January 31, 2024 between the hours of 8:00 AM to 11:00 AM.
- 4. Exhibit space shall be a minimum of 6' x 7' and a maximum of 8' x 10'. Exhibitors may utilize the wall located directly behind them, not exceeding their allotted space. If additional wall dividers are needed, the exhibitor must supply them, not exceeding allotted space. Dividers should not block the flow of traffic in front of the exhibit space.
- 5. Due to the limited number of electrical outlets, access to an electrical outlet must be requested by the exhibitor and may be furnished depending on availability.
- 6. Exhibitors must ensure the display does not interfere with foot traffic.
- 7. Exhibitors must ensure the display area is kept clean at all times.
- 8. The display must stay intact and operate during exhibit hours as follows:
  - Thursday, February 1, 2024, from 1:00 PM to 5:00 PM
  - Friday, February 2, 2024, from 9:00 AM to 5:00 PM
  - Saturday February 3, 2024, from 12:00 PM to 5:00 PM
  - CLOSED SUNDAY February 4, 2024
- 9. The removal deadline for exhibitors to retrieve all exhibit items and remove their exhibit is 4 PM on Monday, February 5, 2024.
- 10. Exhibitors MAY NOT INVOLVE THEMSELVES WITH THE SELLING OF ANY ITEM.
- 11. Exhibitors will be provided with four entry passes.

The display will be the sole responsibility of the exhibitor. The Tohono O'odham Rodeo & Fair Office will not be responsible for the loss or theft of any item from the exhibition area.

I understand that all items not claimed by the removal deadline will be discarded unless prior arrangements have been made. I understand that I may not sell any item at my booth during the exhibit.
