## APPEALS, Article IV, Section 1403, Tohono O'odham Code, Title 12-Elections

Any member of the Nation whose name has been removed from the Official List of Registered Voters or whose name has been omitted in error, or whose name, for other reasons, has not been added to such list by action of the Board after registering in accordance with Article IV, Section 1402, may appeal to the Tohono O'odham Council at least fifteen (15) days prior to the general, primary, or special election. The Tohono O'odham Council shall, if necessary, call a special meeting to decide such appeals. If the Council should decide that the appellant is a qualified voter, it shall order that the appellant's name be placed on the list. The decision of the Council shall be final.
