Items to be reviewed include the following but are not limited to and will be determined by GC: Emergency phone #'s posted. First Aid kits in place and stocked. Someone on the job that is trained in First aid & CPR. Aisles and stairs are free from obstacles & adequately lighted. Work areas generally clean. Holes, stairwells, openings, etc. barricaded. Adequate and clean drinking water with disposable cups available. Material stored safely. Fire prevention equipment available. Waste containers of adequate size. Cords, tools and equipment in good condition, no taped splices. Chemicals, acids, gases, etc.
